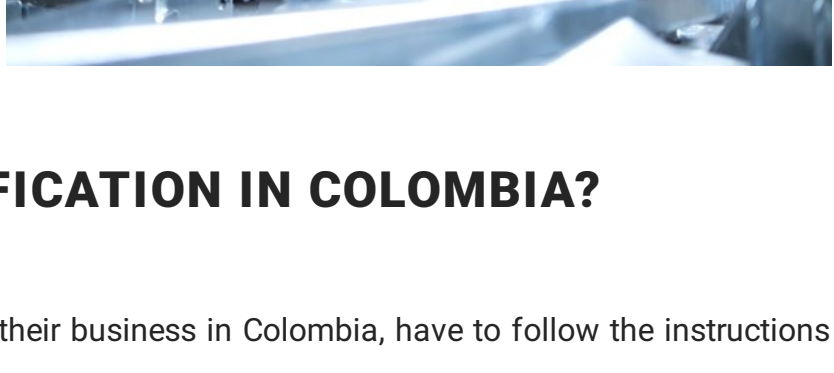

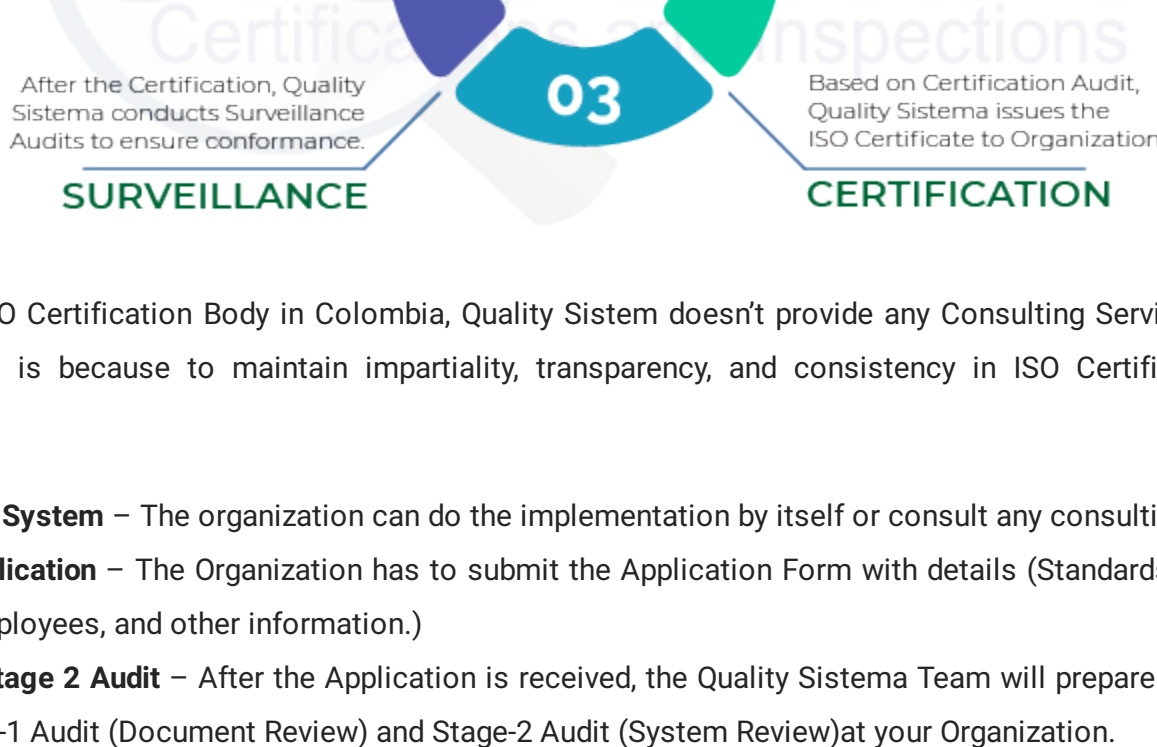

#### Process of ISO Certification in Colombia
